This includes fabrics from the Maharam, Momentum and Spinneybeck upholstery collections and any other fabric not selected from Global's own carded fabrics; within 5 years from the date of purchase in respect of show wood, self-skinned urethane parts, casters, AirSupport air cushion valves, bases, fixed and adjustable arms, stacking/nesting chairs and mechanisms; within 5 years from the date of delivery in respect of pneumatic cylinders and within 2 years in respect of electrical devices (ie. massage mechanisms). Limited Lifetime Warranty is the same as Global's General Seating Line Limited Lifetime Warranty except that these chairs are warranted for multi-shift use and for users weighing up to 250 pounds. **Applies to models 2786-4 and 2787-4 only.** 

## INDUSTRIAL SEATING LIMITED LIFETIME WARRANTY

Under this warranty claims must be made within 2 years from the date of purchase in respect of upholstery, frames, show wood, plastic seat shells, synthetic parts, caster and pneumatic cylinders; within 5 years from the date of purchase in

respect to mechanisms; within 15 years from the date of purchase in respect of non-moving metal components. Warranty is based on an eight hour, single shift work day for users weighing up to 250 pounds.

### ACADEMIC SEATING™ LIMITED LIFETIME WARRANTY

Under this warranty claims must be made within <u>2 years</u> from the date of purchase in respect of upholstery and plastic seat shells; within <u>5 years</u> from the date of purchase in respect to mechanisms, frame, swing arms, tabletops, modesty panels and electrical components; within <u>10 years</u> from the date of purchase in respect of metal posts.

#### FILES LIMITED LIFETIME WARRANTY
